

## **STEAM OVER SHERMAN HILL**

Come, join us for a ride in deluxe Union Pacific passenger equipment behind the world's largest operating steam locomotive. The Rocky Mountain Railroad Club is sponsoring a mainline steam excursion to be powered by Challenger No. 3985. On Saturday morning, June 18, 1988, the Rocky Mountain Railroad Club special excursion will depart Denver Union Station for southern Wyoming.

Diesels will speed our train north over the Union Pacific's Denver-Cheyenne mainline. (Unlike previous years we will not stop in Greeley for passengers.) After climbing through the rolling hills of northern Colorado, we will cross the Wyoming border where Challenger No. 3985 will take charge of our train. We will then begin our climb over Sherman Hill via the Harriman Cutoff. Beyond the summit we will descend into the vast Laramie Valley arriving at the historic Laramie depot after midday. A box lunch will be provided. Departing mid-afternoon, we will proceed east over famed Sherman Hill. Prior to crossing the Colorado border, the mighty Challenger will be removed and diesel power coupled on for the return to Denver.

A number of locations for photo run-bys with this magnificent steam locomotive have been selected at the most scenic sites available for your action shots, movies and sound recordings. Power for recorders is to be available in the baggage car.

Round trip fare for this 300 mile excursion is \$190.00. Tickets should be purchased from the Rocky Mountain Railroad Club as soon as possible. Reservations will be made in receipt of full fare, and will be honored in order of receipt. The Club will make no refunds on reservations canceled after May 18, 1988. Prior to that date, a \$10.00 service charge will be made on each ticket cancelled to help defray handling costs. Acceptance of the Club's rules of conduct is agreed to by passengers when reservations are made. The Club's directors have decided, because of annoyance to passengers, that selling will be permitted on the train only with the express permission of the Club's president.
